The Embassy wishes to advise the Ministry of Interior that the under the federal system in the United States of America, civil matters such as marriage fall under the authority of state and local governments. As an entity of the national government, the Embassy has neither records on the marital status of American citizens nor access to the individual state databases where such information is maintained. The Embassy may however notarize documents such as an Affidavit of Marriage (copy attached) regarding the marital status of American citizens. The American citizen prepares the affidavit by providing the requested information and, under oath, swears to its veracity before a United States Consul.

The Embassy of the United States of America avails itself of this opportunity to renew to the Ministry of Foreign Affairs the assurances of its highest consideration.
