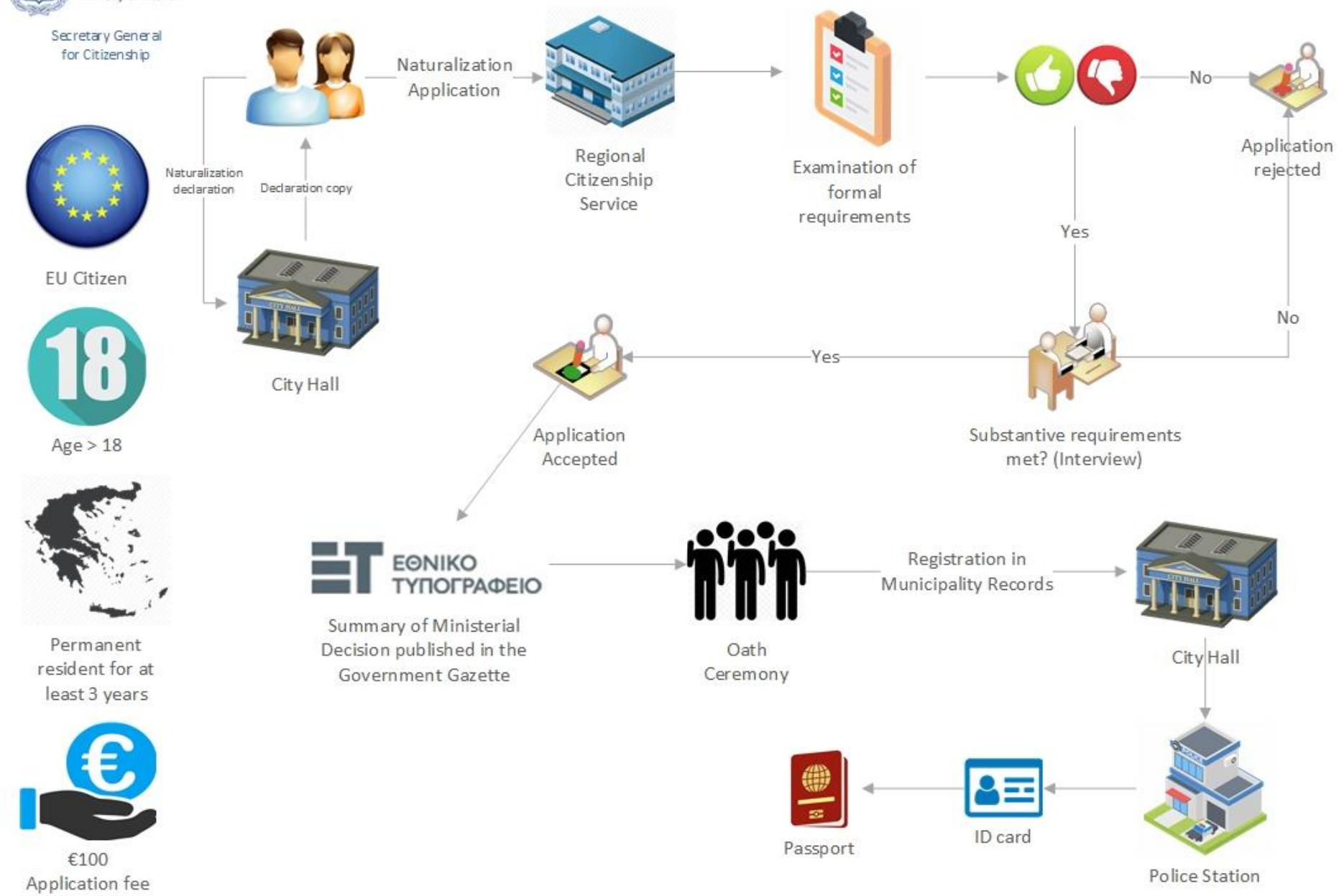

Acquisition of Greek Citizenship by Naturalization, EU citizens

Supporting documents that accompany the Naturalization Application

- ✓ Copy of the naturalization declaration submitted at the Municipality of permanent residence.
- ✓ E.U citizen registration certificate or any other type of residence permit granted to Member State citizens (P.D. 106/2007 A'135)
- ✓ A recent color photograph
- ✓ Exact copy of valid passport or other travel document, or proof of identity, e.g. Identity Card of E.U Citizen.
- ✓ Birth certificate or any other equivalent certificate as provided by the legislation of the issuing country, legally validated and officially translated, or as otherwise specified by current E.U. legislation, e.g. Regulation (EU) 2016/1191.
- ✓ Income tax statements of the three fiscal years corresponding to the years of prior legal residence in Greece.
- ✓ Social Security Registration Number (A.M.K.A.)
- ✓ Application fee of €100 issued on-line

Note: U.K citizens can submit their naturalization application with the above mentioned supporting documents, until the 31st of December 2020.
